Descripti on	Since its launch in 2008, the EURORDIS (Summer) School on Medicines Research & Development has taken place face-to-face every year in Barcelona or online during the COVID pandemic. The Summer School is made up of one week in-person training (usually held in June in Barcelona) following the completion of pre-training modules provided onto the Open academy website.
	The programme aims to provide participants with the knowledge and skills needed to contribute to activities related to medicines research and development. The EURORDIS Summer School training covers topics including: clinical trials methodology, clinical research, ethics in medicines development, regulatory affairs, health technology assessment and marketing authorisation.
	In 2015, a new format was developed for the Summer School that combines training for both expert patients and researchers.
	The Summer School is one of the products of the EURORDIS Open Academy, which encompasses as well the Winter School on translational research.
	Alongside the Schools, e-learning courses are open to anyone to take on the website.
